If your application is successful, we will send you a Production Rights Agreement along with any further details.

The approximate cost of a Production Rights Agreement is 3% of the gross revenue generated using Keith's formats with a yearly minimum payment. This minimum payment is \$200 CAD Note: Exceptions are made for very low GDP Countries. Please contact us for details if needed.

Along with your application form, there is a **ONE TIME ONLY \$50.00 CAD** application fee (Canadian groups, please include \$2.50 GST). Please read to the end of form for details on payment options.

Groups who are part of an educational institution (whether primary, secondary or collegiate) should apply for an Educational Agreement. If you feel you may qualify as an Educational Institution, please contact us for details on applying.
